The Knights of Columbus Holy Family Council #4386 awards up to \$1500 annually for bursaries. The awards are open for any accredited post secondary education. The maximum bursary is \$500. The bursaries will be awarded by a Selection Committee subject to the following conditions:

1. Criteria for Knights of Columbus Holy Family Council #4386 2011 Bursary:
 - a) The applicant must be:
 - i. A member, or son or daughter or legal ward of a member. The member must be in good standing. (Paid-up member of Holy Family Council #4386).

or

 - ii. A son or daughter or legal ward of a Holy Family Council #4386 deceased member in good standing at the time of his death.
 - b) The applicant must be a graduating student from a Windsor-Essex County Secondary School.
 - c) The applicant must provide proof of acceptance in the first year of a recognized post secondary institution and continue in regular attendance for at least one school year.
2. The decision of the Bursary Committee shall be based on faith, academic proficiency, financial need and involvement in school, community and church activities.
3. Power of the Bursary Committee: The decisions of the Committee in making the awards and all decisions of the Bursary Fund and the Administration thereof shall be final.
4. The award shall not be paid until the successful applicant is enrolled and attending the recognized accredited post-secondary institution of his/her choice. One-half (50%) of the bursary will be given at the beginning of the first semester upon proof of enrollment and one-half (50%) will be given in the second semester upon proof of enrollment.
